Bullet Point Analysis

My comments, if any will be within brackets [] and bold in red.

- Datuk Seri Dzulkifly, former Health Minister – No Chinese tourists from Wuhan since 23.1.2020 **[therefore danger is all too apparent]**
- 27.1.2020 statement - Cumulative case for persons suspected to be infected by coronavirus is 38 with one confirmed positive, 32 negative and five waiting for results. As at 3pm Sunday (26.1.2020) 164,692 incoming travellers were screened at our country's entry points, with nine referred for further screening, and none meeting the criteria for Patient Under Investigation for Coronavirus. **[Wuhan, China already in**

lockdown, and DNA sequence of virus communicated to the entire world]

- 27.1.2020 - Hotel and tour agents must alert authorities should clients showed symptoms of novel coronavirus.
- Malaysia which is hosting Visit Malaysia Year 2020, is targeting a high number of tourist arrivals including China. About 3.2 million Chinese tourists visited Malaysia last year. **[Visit Malaysia Year a major factor in decision making, not lives to be saved]**
- Tourism operators should also have preventive measures by distributing masks and sanitisers for their guests and clients.
- 30.1.2020 WHO declares “Global Public Health Emergency”. **[But, under PH no emergencies measures were adopted. PH still focused on power grab etc. WHO cries Fire, Fire but PH government does not send medical fire brigades to put out the infectious fires. OMG!]**
- 4.2.2020 Tourism Minister, Datuk Mohamaddin Ketapi – Malaysia has banned flights from Hubei, China. No issuance of visas from that province. Sabah and Sarawak... has imposed total ban of visitors from China.
- China represents 11% of Malaysia total market share. Government’s target of 30 million foreign tourist arrivals and RM100 Billion receipts for Visit Malaysia Year 2020 remains unchanged. **[Still money centric approach. No Risk Analysis approach. RM Billions still driving the narrative]**
- Feb. 19, 2020 – PH Health Minister – Spread of coronavirus very well contained. Malaysia has 3rd highest number of cases behind Singapore and Thailand – 22 cases. Malaysia on serious alert for coronavirus. **No cause for panic...! [No sense of urgencies. Italy is out of sight and out of mind]**
- Country not at stage of closing schools. **[Danger apparent but no action taken again.]**
- Read the entire speech of Tun M on PH’s stimulus package of RM20 billion on 27.2.2020 because of the impact of coronavirus on Malaysian economy. Nothing to do with the Trade War between China and USA.

Excerpts:

“...the government will introduce 2020 Economic Stimulus Package to ensure risks associated with the outbreak is effectively addressed” (para 3 of speech)

“Three strategies – (1) Mitigating Impact of Covid 19 (2) Spurring Rakyat Centric Economic Growth and (3) Providing Quality Investments..” (para 4 of speech)

[All about economy (monies), not one word on preventing and saving lives – A Cost / Benefit Analysis and not a Risks (Reversible and Irreversible) Analysis. This comment applies to all the Bullet Points where applicable, especially on “Visit Malaysia Year 2020”].

Final Review

Some of you may well argue that the present PM who was the then Home Minister ought to be implicated. Absolute nonsense because the lead Minister for the crisis, is the then Health Minister, followed by the then supporting ministers, Tourism and Finance. If these three jokers fail to stress the national security aspects to the Home Minister, PM and the Cabinet adopts the flippant attitude (because of the power grab and Visit Malaysia Year 2020 diversions) the Home Minister has no basis to advise on convening the NSC and imposing drastic measures.
