

NEW WORLD ORDER – Post Covid19

This is **Part 2** of the article which I had sent out via Whatsapp yesterday.

I had already warned that the West led by the US and for reasons of geopolitics and domestic elections are hell bent to destroy China and Russia economically and financially to maintain the US\$ as the world's only Reserve Currency and the West's dominance in global affairs.

There is now a massive propaganda that China (Wuhan) is the cause of the coronavirus pandemic, ***distorting specifically the Report from the “Five Eyes” Intelligence Alliance*** comprising Australia, Canada, New Zealand, the United Kingdom and the United States, supposedly alleging the culpability of China. The Guardian, UK reported:

Five Eyes network contradicts theory Covid-19 leaked from lab.

No current evidence to suggest coronavirus leaked from Wuhan research lab, agencies say. There is no current evidence to suggest that coronavirus leaked from a Chinese research laboratory, intelligence sources have told the Guardian, contradicting recent White House claims that there is growing proof this is how the pandemic began.

The sources also insisted that a “15-page dossier” highlighted by the Australian Daily Telegraph which accused China of a deadly cover up was not culled from intelligence from the Five Eyes network, an alliance between the UK, US, Australia, New Zealand and Canada. There is nothing to indicate a leak from the lab could have caused the pandemic, sources say.

Claims are even made that the virus was genetically engineered in Wuhan, although there is both scientific and intelligence agency agreement that there is no evidence for this.

Key U.S. Allies Skeptical of Trump's Coronavirus Lab Leak Claims.

Five Eyes members and intelligence analysts push back against attempts to pin the virus on Chinese biosafety mistakes.

The US are covering up and inciting the blame game because they have to divert the world's attention to a horrendous fact that the particular strain of Covid 19 ravaging the entire Western world (G614) is not the same as the strain

that ravaged Wuhan (D614). The former G614 came from Italy. The picture below paints more than a thousand words. It is extracted from the Fig 1.3, page 18 of the Report from the Los Alamos National Laboratory.

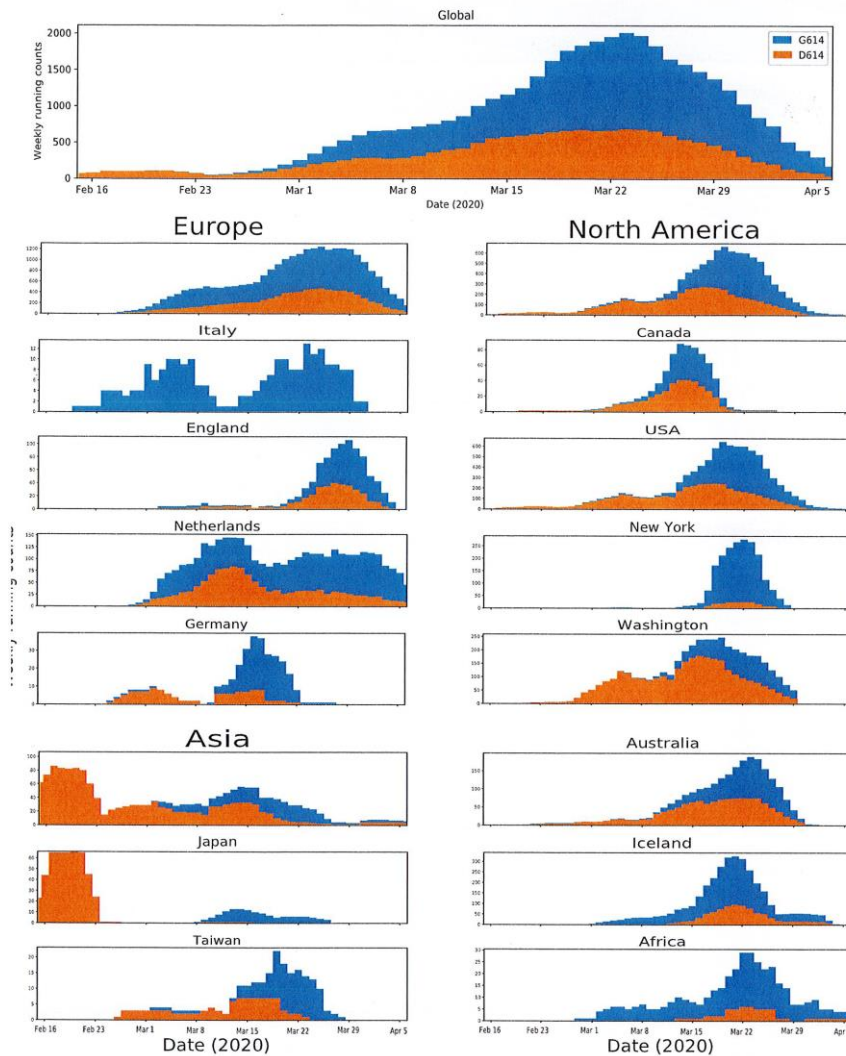


Fig. 3. Running weekly average counts showing the relative amount of D614 (orange) and G614 (blue) in different regions of the world. In almost every case soon after G614 enters a region, it begins to dominate the sample. Fig. S3 shows the same data, illustrated as a daily cumulative plot. Plots were generated with Python Matplotlib (Hunter, 2007). The plots shown here in Fig. S3 can be recreated with contemporary data from GISAID at www.cov.lanl.gov.

The “Blue” G614 strain from the global and western countries perspective has been and is the dominant strain, while the Orange D614 strain that first spread in Wuhan was not the dominant strain. And why was Italy having only the Blue, G614 strain which spread to the rest of the world?

The Russian foreign ministry was reacting to a State Department paper released last week that says placing low-yield nuclear weapons on ballistic missiles launched from submarines would counter what it sees as possible new threats from both Russia and China.

Malaysians may very well ask, "What the hell is going on when humanity is confronting the deadly Covid19 pandemic?"

This global threat by the West is nothing new or surprising for those of us following the insidious agenda of the false Muslim Obama/Hillary Clinton Cabal for global dominance. Obama's most virulent mouthpiece, was and still is Edward Fishman who was a member of Obama's Policy Planning Staff at the State Department and is now a non-resident senior fellow at the Atlantic Council and an adjunct fellow at the Center for a New American Security (an echo of the Neo-cons' Project For A New American Century)

On 5.3.2020, Fishman published an article in Politico which, I shall quote in extenso, so that all of you can fully appreciate this political harlot's demonic vision for the world, post Covid 19:

... At rare moments, confidence in the old order collapses and humanity is left with a vacuum. It is during these times that new orders are born—that new norms, treaties and institutions arise to define how countries interact with each other and how individuals interact with the world.

As the most far-reaching global disruption since World War II, the coronavirus pandemic is such a moment. The post-1945 world order has ceased to function. Under a healthy order, we would expect at least good faith attempts at international coordination to confront a virus that knows no borders. Yet the United Nations has gone missing, the World Health Organization has become a political football and borders have closed not only between countries but even within the European Union. Habits of cooperation that took decades to entrench are dissolving.

Whether we like it or not, a new order will emerge as the pandemic recedes. U.S. leaders should do everything in their power to ensure

that the post-coronavirus order is equipped to tackle the challenges of the coming era.

Five years ago, I represented the State Department in an interagency project to evaluate the future of the international order. We studied past transitions and discussed possible reforms. We recognized that the order was fragile and needed repair, but we also appreciated the power of inertia—it takes extreme moments for leaders to accept that the old order is broken and summon the will to forge a new one.

Consider the lessons of America's last two major attempts to build international orders—in 1919 after World War I and in 1945 following World War II. The post-1919 order was marked by the Great Depression, the rise of totalitarian regimes and eventually a conflagration even more devastating than World War I. By contrast, the post-1945 order led to more than seven decades of peace and prosperity, in which violent deaths plummeted and world gross domestic product expanded at least eightyfold.

How can America avoid the errors of post-1919 and emulate the successes of post-1945? Three primary factors distinguish the two projects.

First, U.S. leaders should plan for the new order right now, as the crisis is on-going. When President Woodrow Wilson arrived at the Paris Peace Conference in January 1919, two months after the war had ended, none of the core principles of the post-war order had yet been agreed. Consequently, the allies' deliberations were plagued by contradictory agendas, resulting in a pact incapable of managing the problems of the world to come.

Conversely, President Franklin Roosevelt began planning for the post-World War II settlement before the United States even entered the war. America and Britain issued the Atlantic Charter, which articulated their goals for the post-war order, in August 1941—four months prior to Pearl Harbor. The Bretton Woods Conference, which outlined the post-war economic system, took place in July 1944. By the time the war ended in 1945, the tenets of the new order were already well established, enabling the allies to focus on the critical details of implementation.

The coronavirus will arrest our lives longer than we'd like, but not forever—and when the crisis passes, the contours of the new order will take shape rapidly. To ensure that brief window is put to good use and not consumed by squabbling, U.S. and world leaders should begin collaborating now to formulate principles.

...we need a revamped order among like-minded democracies—which, as a smaller group, can be more ambitious. The United States and its allies in Europe and Asia should come together into a council

of democracies, expanding collective defense beyond the military realm to counter subtler menaces such as election meddling, disinformation and financial coercion. On the economic front, it's well past time for an international system that prioritizes human welfare over growth for growth's sake. America, the EU, Japan and other democracies should seal new economic agreements in which increasing market access goes hand-in-hand with cracking down on tax avoidance, protecting data privacy and enforcing labour standards. Some level of pullback from globalization is inevitable and warranted. But absent planning now, that retreat will be chaotic and blunt, throwing the baby out with the bathwater.

It is clear that we must go behind the printed words and the nuances and examine WHAT IS NOT SAID AND WRITTEN which would be more revealing to the discerning reader - The ABSENCE OF ANY MENTION OF THE ROLES OF THE BRICS COUNTRIES, SPECIFICALLY RUSSIA AND CHINA IS TELLING.

Prabir Purkayastha put it well when he wrote,

“But that is not all. The anti-China campaign fits into the larger war that the United States was already waging against China. The US hegemony as the sole superpower is being challenged – economically by China with its manufacturing strength, and strategically by Russia, with its re-emergence as a global player. In the US domestic politics and its presidential election cycle, Russia is rapidly replaced by China as the new arch villain.”

That is why, time after time when discussing with academics, brainwashed political analysts and policy hacks, they just echo the written words as the mantra to be recited.

It is fundamental for genuine truth seekers to remember that, ***what is not said and or written is more revealing than the spoken or written words*** because the unspoken agenda must be kept away from the “Deplorables” (to borrow the expression of Hillary’s contempt for the masses) save those who have been initiated and admitted to the inner sanctum of the Guardians of Global Affairs.

To conclude, let me quote once again Prabir’s timely observation and warning:

Can they do this with China – for instance, refusing to pay back the \$1.1 trillion that the United States owes China as a debt? Or will any such

overreach finally sink the dollar as countries realise the risk in making the dollar, the de facto global reserve currency?"

And I take much comfort that another global observer has echoed what I had observed in 2015 when preparing the speech for Tun Mahathir Mohammad in the Closed Door Dialogue for selected attendees. In the case of Malaysia, I had already observed, and I quote:

Major National Fractures

Loss of oil revenues and its impact;

High levels of leverage by public and private corporations;

High level of consumer debts;

Massive property overhang and social problems resulting from inadequate housing;

Growing economic inequalities;

Collapse of political cohesion.

With regard to Major Global Fractures, my observations are too extensive to be reproduced here, suffice to say, that what has been observed are now unravelling.
