

The DNA Of Coups & Regime Change - Ukraine, Hong Kong, Syria and USA!

Introduction

Please ensure that the statements below are kept in mind when reading the rest of the article. Presidents, Prime Ministers, Absolute Monarchs and Dictators wield power at the behest of those who have put them in power and or tolerated their continuance when they are still useful.

You may recall that President Trump recently declared that the King of Saudi Arabia can survive only two weeks in power should the US decide to withdraw its support (as have all previous presidents indicated). During the 1997 ASEAN Financial Crisis, President Suharto of Indonesia resigned after an US aircraft carrier was stationed off the coast of Indonesia and Madeline Albright signalled that he was no longer useful and was forced to sign an agreement with the IMF in the presence of Michel Camdessus, the then Managing Director (16 January 1987 to 14 February 2000) hovering over Suharto, arms folded signifying total dominance over him.

All **politicians** are **mere instruments** of those who wield **real power**.

All political **parties** are of necessity made up of **different factions and agendas**.

Democracy is **a useful myth** and a mere **ideological tool** for control.

Compromises are temporary and the **prerequisite for survival**.

Why Coups?

Britannica defines coup as follows:

Coup d'état, also called **coup**, the sudden, violent overthrow of an existing government by a small group. The chief prerequisite for a coup is control of all or part of the armed forces, the police, and other military elements. Unlike a revolution, which is usually achieved by large numbers of people working for basic social, economic, and political change, **a coup is a change in power from the top that merely results in the abrupt replacement of leading government personnel. A coup rarely alters a nation's fundamental social and economic policies, nor does it significantly redistribute power among competing political groups.**

It is enough for the purposes of this article to examine the coups and attempted coups in recent times to better appreciate the complexities and nuances of the **“protests”** and **violence** sweeping across the USA.

In essence, the present riots sweeping across USA is a coup unleashed by the Deep State to topple President Trump.

And as stated above, a coup is a change in power from the top that merely results in the abrupt replacement of leading government personnel. A coup rarely alters a nation's fundamental social and economic policies, nor does it significantly redistribute power among competing political groups.

There is no fundamental differences between the Republican Party and the Democratic Party in USA and the Conservative and Labour Parties in the UK etc. They all serve the objectives of the vested interests.

It is incumbent in the study of coups that we understand how **“protests”** and contrived **“violence”** are utilised to achieve the objectives of changing the power equation in a country. We shall now proceed to examine some recent examples.

Ukraine

Stratfor, the most powerful private intelligence organisation, often referred to as the **“Shadow CIA”** describes the overthrow in 2014 of the democratically elected government in Ukraine by the then Obama regime as **“the most blatant coup in history”**.

Victoria Nuland, who was the former Assistant Secretary of State for Europe and Eurasian Affairs was a central figure in the coup and even picked the then incoming prime minister after the coup was effected. Google and fact check!

The CIA pitted neo-Nazi forces against Russians and Jewish citizens inciting racial hatred which resulted in massive demonstrations and **“protests” (Step 1)**. It was inevitable that the government would respond by deploying police and

the military to control the situation **(Step 2)**. The coup plotters **infiltrated the ranks of the demonstrators with instigators to unleash violence** – looting, burning of vehicles, shops and government buildings etc. **(Step 3)**. Professional snipers were directed to **shoot at the protestors (Step 4)** which would ensure a violent reaction and the accusations that the government was condoning police brutality and violence. It would be a matter of time for the protestors to demand the **ouster of the government (Step 5)**.

Hong Kong

The same modus operandi (Steps 1 to 5 above) was applied in Hong Kong by foreign intelligence personnel – USA, UK etc. Videos have gone viral showing US State Department officials briefing the youth leaders and other foreigners inciting the protestors to confront and beat up the police and perpetrated other acts of violence. But, the coup failed and the ultimate objective to have Hong Kong secede from China as an independent state could not be achieved. But, we must take note the modus operandi.

Syria

The same modus operandi (Step 1 to 5 above) was applied in Syria. But the CIA etc. used an **additional tool** when the **protests** and demonstrations failed to topple President Bashar Assad – **the use of ISIS, Al Qaeda etc. as mercenaries to unleash a civil war (the use of violence)**. But, for the Russian intervention and later the assistance of Iran, Iraq and Hezbollah, the coup would have succeeded. The US objectives for Syria have now changed.

Recently, U.S. special representative for Syria, James Jeffrey, in a Hudson Institute video call, has urged continued American deployment to the war torn country in order **to keep pressure on U.S. enemies and make the conflict a "quagmire" for Russia**. The coup, having failed morphed into an **asymmetric warfare** with Russia.

In the above three examples, the coups were instituted by the US and British intelligence apparatus for their geopolitical agendas. They were part of the regime change agenda to ensure subservience and compliance to US policies. In the above circumstances, it was a bipartisan effort by the US elite establishment.

However, what has caused the confusion regarding the events unfolding in the USA presently, is the assumption that coups are not an option by political forces as the US is perceived as the most “democratic country” in the world. However, even the most sophisticated analysts got it so wrong because they failed to recognise the **“Silent Coups”** the use of various institutions (FBI, DOJ, NSC etc.) to investigate a president to force and or blackmail him to resign from office as in the case of President Nixon and when that failed, an assassination would be the ultimate fall-back as in the case of president Abraham Lincoln, John F. Kennedy, and attempts as in the case of President Ronald Reagan.

Impeachment of a president is by any measure a “silent coup” but much harder to execute.

USA – The Karmic Backlash

What is happening in the US is a well-conceived and brilliant strategy by the Deep State coup plotters. The Trump administration, for the purposes of US geopolitical agenda was manipulated into supporting the “**protestors**” in Hong Kong as part of the global struggle to maintain US hegemony.

Notice that the core group of provocateurs were all dressed in black, wearing masks and were well equipped. All you need is to compare the pictures of the rioting in Hong Kong with those in the US. It is identical with regard to the core team of provocateurs. The peaceful protestors were in their ordinary clothes. But the inciters and instigators were all in black clothes.

The current riots is the Final Stage by the Deep State and its political tools (the Democrats / Liberals) to seize back power after the humiliating defeat of Hillary Clinton in the 2017 Presidential Elections.

The “Silent Coup” modus operandi was first used in the case of President Trump, when the coup plotters headed by the Obama / Hillary cabal realised in 2016 that Trump would be the nominee of the Republican Party and would in fact win the election in 2017. As early as 2016, the coup plotters started the “**Russian Collusion Hoax**” as a smear campaign to derail the election of Trump. When Trump was inaugurated in 2017, the coup took the form of a **Special Prosecutor Investigation** (the Mueller Investigation) which failed to find any evidence of criminality against Trump. In 2018, when the Democrats took control of the House of Representatives, they immediately launched the **impeachment** of Trump but that effort also failed.

There were several attempts at assassination but the hired guns failed to zero-in their target!

The present massive peaceful “**protests**” and demonstrations to demand justice for the murder of a “Black American” by a white police officer is an excellent cover for the coup.

However, as in the above examples, the said protests have all been hijacked by “**planted provocateurs**” inciting **violence** which have resulted in lootings, burnings, killings of policemen, shop keepers defending their shops, and the burning of a church.

Democratic Governors and Mayors are giving “**stand-down**” orders to the police - not to intervene to stop the violence on the **spurious ground that the protestors and demonstrators must have their day in the streets to “vent**

Zero Hedge, citing JustTheNews, reported that law enforcement officials across the country have said the anarchists who are inflaming peaceful demonstrations honouring George Floyd and transforming them into violent riots are **more organized, better coordinated and supplied than any militants seen in civil discord in years.** Police intelligence units have **uncovered encrypted and walkie-talkie communications** as well as social media postings that coordinate the **delivery and hiding of weapons and projectiles and the direction of anarchists to specific locations at specific times.**

In essence, these professional rioters have created command-and-control apparatus as well as supply chains unseen in prior riots that followed the deaths of Michael Brown (Ferguson, Mo.) and Freddie Grey (Baltimore) and the verdict in the case of those officers who beat Rodney King (Los Angeles). Intelligence had revealed calls for violence against the police, and officers found caches of glass bottles, baseball bats and metal poles hidden along the street.

In other cities, stacks of bricks have been discovered in staging areas that end up being slammed against store windows by looters.

The anarchists have developed a complex network of bicycle scouts to move ahead of demonstrators in different directions of where police were and where police were not for purposes of being able to direct groups from the larger group to places where they could commit acts of vandalism including the torching of police vehicles with molotov cocktails where they thought police officers would not be.

The pre-planning by the anarchists included the preparation of **supply lines for such items as gasoline, bottles and rocks as well as medics who could care for injured rioters.**

Before the protests began, organizers of certain anarchist groups **set out to raise bail money and people who would be responsible to be raising bail money, they set out to recruit medics and medical teams with gear to deploy in anticipation of violent interactions with police,** The goal of the anarchists appears to be to instigate large numbers of locals to create chaos and additional violence and looting. **About one out of every seven people arrested by the NYPD were outsiders aligned to such anarchist groups.**

The objective of the nationwide unrest unleashed thus far, is to ensure that Trump is unelectable in the November Presidential elections.

The November election is a fiction, a convenient cover for the coup to oust Trump which prior to the current violence was polled to win the election by a landslide including democratic controlled states.

Rules and laws are being changed to allow for **“mail-voting”** and Democratic Party elections officials have been charged for vote rigging in favour of presidential nominee Joe Biden during the Primary Elections to select the nominees to contest against Trump.
