Why?

## **(A) First Situation**

Under **ARTICLE 55 (2)** of the Constitution, the **Yang di-Pertuan Agong (the King) may PROROGUE or DISSOLVE parliament.**

To prorogue parliament means, to suspend parliament for whatever period the Agong deems fit. **And it is not necessary to do so only in an emergency.**

AT ANYTIME! The Agong can do this at any time. The customs and practices of the British parliament, when "parliament is prorogued" does not apply to Malaysia because in UK, Parliament is supreme and must follow its own procedures and also because they don't have a constitution.

**In Malaysia, our CONSTITUTION is supreme.** So, don't be misled by those arsehole lawyers, fifth columnists and supporters of Anwar, who say otherwise. How can you trust them when these scumbags have advised Anwar to execute the coup.

**Article 40 (2)** of our Constitution refers to **AGONG's discretion** and this discretion is wide and exercisable beyond Article 40 (2):

(a) ... *not applicable*

(b) which refers to the withholding of consent to dissolve parliament and  
(c) .... *Not applicable*

At the end of Article 40(2) it is stated expressly:

**"and in other cases mentioned in this constitution."**

**This means, Agong's discretion is wide and not confined only to Article 40(2) itself.**

**Article 55 (2)** is clear that the Agong is acting at his sole discretion when reading the provision in conjunction with ARTICLE 42(2).

More importantly, Article 55(5) provides that a Bill pending in parliament shall not lapse by reason of the prorogation of parliament.

### **(B) Second Situation**

The **National Security Council Act** is now in full operation and made operative by virtue of the Covid19 pandemic. The PM and AGONG has all the powers to ensure THE SAFETY of our country.

The Agong has directed that all politicians should be aware of the situation of the Covid19 pandemic and to safeguard the country. The Agong warned the politicians to stop politicking and misbehaving, and more importantly abusing parliament.

The full force of law of the National Security Council Act is applicable now. **The NSC is in full session EVERYDAY, since MCO was imposed.**

Therefore PM and the PN GOVT should demand full compliance and adherence of the law.
