

# Why Constitutionalists In Malaysia Are Hypocrites. The Coup Plotters Led By The Tri-Fecta of Najib, Zahid And Anwar Together With Tun Mahathir's Camp **Are Traitors To The Constitution.**

## Introduction

Yet, in the midst of the criminal coup, these so-called constitutionalists have remained on the side-lines and kept their mouth shut wallowing in the shithole of ego-centric VIPs. Their silence is deafening. This sordid behaviour, in the light of the insidious frontal assault on the Agong and the Sultans, is hypocritical and unbecoming when the prestigious awards they have received were conferred by the Sultans and His Majesty, Agong – the Tuns, the Tan Sris, the Datuks etc!

Now, do you see the problem with this bunch of so-called Constitutionalists?

Before proceeding further and to avoid any misunderstanding, may I share with you the relevant definition.

**Constitutionalism** is "a compound of ideas, attitudes, and patterns of behaviour elaborating the principle that the authority of government derives from and is limited by a body of fundamental law". Therefore, a Constitutionalist subscribes to this fundamental concept.

**Malaysia has a Constitution, which is the Supreme Law of the land. There are certain entrenched and fundamental provisions which make our Constitution unique, inter-alia, those provisions that relate to the Agong (the King) and the Rulers of their respective states.**

At this juncture, I have to mention that the majority of these constitutionalists are Anglophiles, but nevertheless have misapplied the concept of “parliamentary democracy” in addressing constitutional issues and or crisis in Malaysia, a futile exercise in trying to put round pegs in square holes.

That said, it is not disputed that the Queen of UK is a Constitutional Monarch and all that the term entails.

To illustrate, let me cite one example. In UK, the government of the day (be it Labour or Conservative) is officially referred to as **“Her Majesty’s Government” and all that the term implies.**

Please fact check, if you dare to contradict me and the below official statement:

**The Government of the United Kingdom, formally and commonly referred to as Her Majesty’s Government, is the central government of the United Kingdom of Great Britain and Northern Ireland.**

One may argue, it is a mere formality but practice shows that proper respect has always been extended to the sovereign of the day, thus if it is the King, the reference is to His Majesty and if a Queen, Her Majesty!

### **Agong In Malaysia’s Constitution**

We assert without any reservations that any assault on the Agong and the Rulers without any justification or basis is in itself seditious and a blatant attempt to undermine the institution of Constitutional Monarchy. And a coup against the Agong, disguised as a coup against the Prime Minister is by any measure, a coup against the Constitution, more so in the recent developments following the opportunistic resignation of Tun Mahathir as Prime Minister in February, 2020.

**With the collapse of the PH moribund regime, there ought to be a general election for a new government to be emplaced. But, all 222 members of parliament requested the Agong to exercise his discretion under the Constitution to appoint a new Prime Minister and to form a new government.**

However, a small group of MPs led by Tun Mahathir (Tun M) were dissatisfied with the appointment of Tan Sri Muhyiddin Yasin (TSMY) as they had hoped to be chosen instead. At once, TSMY was attacked mercilessly and supported by foreign bloggers (led by a self-appointed pseudo Joan of Arch of Malaysia) and scandalously called TSMY and his government as a “Back-Door Government” by virtue of his appointment by the Agong. Yet, it was all these scumbags who lobbied to be so appointed by the Agong. The irony being, if they were to be appointed by Agong as Prime Minister, it would be a “Legitimate Front Door government” even though there was no General Election.

Such is the hypocrisy!

A massive campaign was launched against the Agong and the Prime Minister distracting the entire country from the more urgent crisis, to defeat the Global Covid19 pandemic.

Let's get down to specifics – who is Agong in our Constitution? We need only to cite the main Articles of the Constitution.

### **Article 39 - Executive Authority of Federation**

**The executive authority of the Federation shall be vested in the Yang di-Pertuan Agong and exercisable, subject to the provisions of any federal laws and of the Second Schedule, by him or by the Cabinet or any Minister or any Minister authorised by the Cabinet, but Parliament may by law confer executive functions on other persons.**

### **Article 40 (2)**

**The Yang di-Pertuan Agong may act in his discretion in the performance of the following functions, that is to say:**

- (a) The appointment of a Prime Minister;**
- (b) The withholding of consent to a request for the dissolution of Parliament;**
- (c) The requisition of a meeting of the Conference of Rulers concerned solely with the privileges, positions, honours and dignities of Their Royal Highnesses, and any action at such meetings**

**and in any other cases in this Constitution.**

### **Article 41 Supreme command of armed forces**

**The Yang di-Pertuan Agong shall be the Supreme Commander of the armed forces of the Federation.**

### **Article 43 Cabinet**

- (1)The Yang di-Pertuan Agong shall appoint a Jemaah Menteri (Cabinet of Ministers) to advise him in the exercise of his functions.**

**[Comments by Matthias Chang – Hence any government must be rightly called “His Majesty’s Government.” Period! This is strengthened by the below provisions.]**

- (2)The Cabinet shall be appointed as follows, that is to say:**
  - (a) The Yang di-Pertuan Agong shall first appoint as Perdana Menteri (Prime Minister) to preside over the Cabinet a member of the House of Representatives who in his judgment is likely to**

- command the confidence of the majority of the members of the House; and**
- (b) He shall on the advice of the Prime Minister appoint other Menteri (Ministers) from among the members of either House of Parliament.**

#### **Article 55 Summoning, prorogation and dissolution of Parliament**

- (1) The Yang di-Pertuan Agong shall from time to time summon Parliament and shall not allow six months to elapse between the last sitting in one session and the date appointed for the first meeting in the next session.**
- (2) The Yang di-Pertuan Agong may prorogue or dissolve Parliament.**

#### **Article 137 Armed Forces Council**

**There shall be an armed Forces Council, which shall be responsible under the general authority of the Yang di-Pertuan Agong for the command, discipline and administration of, and other matters relating to, the armed forces, other than matters relating to operational use.**

**[Comments by Matthias Chang - Who do you think appoints the Chief of Defence Forces and the respective Heads of the Army, Navy and Air Force??? Yes, it is the Agong!]**

#### **Conclusions**

**The above are some of the Articles in our constitution and I have quoted in some references to the entire article and some other, part of the article for sake of space and brevity, which in such cases would not have affected the full import of the referenced Article.**

**Can anyone therefore argue that the government in Malaysia is NOT His Majesty's Government as in the case of UK (see above) when the government is also referred to as "Her Majesty's government".**

**The Cabinet is also appointed by the Agong.**

**And more importantly, in Article 41 and 137 relating to the Armed Forces, the Agong is the Commander in Chief and responsible for all the key appointments.**

**So, when there is a coup against the government, it is also a coup against the Agong and the respective Rulers as constituted in the Conference of Rulers.**
