

# Seeing Through The Fog of War – Understanding what Are the Consequences of A Proclamation of Emergency – First In Malaysia & Secondly in USA

## Prologue

Anwar Ibrahim and former Attorney General, Tommy Thomas are idiots and by their statements regarding the Proclamation of Emergency have committed the crime of sedition and whatever other crimes applicable under the Penal Code. So, don't be fools and follow their actions like sheeples!

## **Essence Of This Article**

From 11<sup>th</sup> January 2021, the entire country is to be governed by the above-stated Ordinance and other applicable laws. Any defiance or subversion of the Proclamation is an offence under the Security Law(s) promulgated under the above-stated Ordinance.

Take Note of the Preamble of the Ordinance:

**“WHEREAS by reason of the existence of a grave emergency threatening the security, economic life and public order of the Federation arising from the epidemic of an infectious disease, namely Corona Virus Disease 2019 (Covid19), a Proclamation of Emergency has been issued by the Yang di-Pertuan AGONG under Article 150 of the Federal Constitution on this eleventh day of January, two thousand twenty one:**

**“AND WHEREAS the Yang di-Pertuan AGONG is satisfied that IMMEDIATE ACTION is required to guarantee and preserve the security, economic life and public order.....”**

### **Warning To All**

**Specific warning to Anwar, Tommy Thomas et al – Stop your nonsense or you will face the full weight of National Security Laws!**

You need to read for yourself the entire Article 150 of our Constitution to appreciate the full implications of the Proclamation of Emergency. Additionally, you must read Articles 39 (Executive Authority) and 41 (Supreme Commander-in-Chief) with Article 150 (8) of the Constitution.

### **Article 150(8) provides**

Notwithstanding anything in this Constitution -:

- (a) the satisfaction of the Yang di-Pertuan Agong mentioned in Clause (1) and Clause 2(b) shall be final and conclusive and **shall not be challenged or called in question in any court on any ground**; and
- (b) **no court shall have jurisdiction to entertain or determine** any application, question or proceeding, in whatever form, on any ground, regarding the validity of –
  - (i) a Proclamation under Clause (1) or the declaration made in such Proclamation to the effect stated in Clause (1);
  - (ii) the continued operation of such Proclamation;
  - (iii) any ordinance promulgated under clause 2(b); or
  - (iv) the continuation in force of any such ordinance.

**You must be an arsehole, if you still entertain the nonsense that the Agong is a mere puppet and or a figurehead!**

To assist the AGONG, there shall be established an Independent Special Committee. See **Section 2 (1)** of the said ordinance.

**Section 2(2)** The members of the Independent Special Committee SHALL **be appointed by the Yang di-Pertuan Agong.**

### **Section 7 (1) of the ordinance**

For as long as the emergency is in force, the armed forces, upon the direction by the Yang di-Pertuan Agong or any person authorised by the Yang di-Pertuan Agong, SHALL have all the powers of a police officer of whatever rank as provided under the Criminal Procedure Code [Act 593] and such powers shall be in addition to the powers provided for under the Armed Forces Act [Act77] and not in derogation thereof.

### **Section 7(2)**

For the purposes of this section, “armed forces” SHALL have the meaning assigned to it in section 2 of the Armed Forces Act 1972.

## **THE USA SITUATION**

I have no wish to refer to all the relevant laws governing a state of emergency and or war in the USA. Suffice to say that the laws in the USA are more extensive than those in Malaysia.

What we must all take cognisance of is that President Trump has declared **that the 3<sup>rd</sup> November Election to be a National Emergency and placed the United States into a state of war lasting from May 2020 to May 2021** (as most people, Americans and foreigners have overlooked).

However, in the USA, there is also the provision for the **“Continuity of Government” (COG) in times of emergencies.**

**Additionally, Continuity of Operations (COOP)** is a United States federal government initiative, required by U.S. Presidential Policy Directive (PPD), to ensure that agencies are able to continue performance of essential functions under a broad range of circumstances. PPD specifies certain requirements for continuity plan development, including the requirement that all federal executive branch departments and agencies develop an integrated, overlapping continuity capability, that supports the eight National Essential Functions (NEFs) described in the document.

The **Federal Emergency Management Agency [FEMA]** provides guidance to the private sector for business continuity planning purposes. A continuity plan is essential to help identify critical functions and develop preventative measures to continue functions should disruption occur.

## **The Shadow Government**

Following a catastrophic national emergency, the President, or his successor can authorize the establishment of a temporary "shadow government" to maintain control of the essential functions of the Federal Government. President Bush activated the shadow government on September 11, 2001 shortly after the second attack on the World Trade Centre.
