

Why Is There Almost Total Silence From The Medical Profession In Malaysia On Safety Issues Regarding Covid19 Vaccines When Global Medical Specialist Are Sounding Alarm Bells?

In today's posting we are greatly indebted to a very courageous and honest medical specialist of Thai descent, Professor Sucharit Bhakdi, who together with his colleagues at the [“Doctors For Covid Ethics”](#) were compelled to issue an Open Letter to the world, when the [European Medicines Agency](#) [refused to reply](#) to their letter expressing their concerns on the safety of the various vaccines rolled out for mass vaccination.

Just a few days ago, it was widely reported and a video was posted in the global social media, showing medical experts of Thailand withdrawing / suspending the inoculation of Thailand's Prime Minister as a result of safety concerns relating to the [AstraZeneca vaccine](#) pending a fuller investigation on deaths and serious side effects (e.g. blood clotting) following vaccination of certain patients in Europe. It is admirable that Thailand has put safety and interest of the entire nation first and not rush to mass vaccinate her people.

We are also [uploading the Video of Prof Sucharit Bhakdi](#) explaining the stance taken by him and his colleagues, and highlighting inter-alia, the danger of blood clotting following the vaccination of the AstraZeneca vaccine, for which the vaccine manufacturer brushed aside as having no causal connection even as there are on-going investigations. Interestingly blood clotting was one of the a major concerns.

Reuters had even reported on 15.3.2021 and we quote:

“A 60-year-old Danish woman who died of a [blood clot](#) after receiving AstraZeneca's [COVID-19 vaccine](#) had “highly


unusual” symptoms, according to the [Danish Medicines Agency](#). The woman had a low number of blood platelets and clots in small and large vessels, as well as bleeding, it said. A few similar cases were found in Norway and in the [European Medicines Agency’s \(EMA\) database of drug side effects](#), the Danish Medicines Agency said.

“It was an unusual course of illness around the death that made the Danish Medicines Agency react,” it said in a statement late on March 14. Norway said on Saturday that three people, all under the age of 50, who had received the AstraZeneca vaccine were being treated in hospital for bleeding, blood clots, and a low count of blood platelets, which were labelled “unusual symptoms” by health authorities. Denmark, Norway, and Iceland said last week they would halt the introduction of the AstraZeneca vaccine.

European vaccination programs have been upset in the last two weeks by reports that recipients of the AstraZeneca inoculation have suffered blood clots.”

That said, we should all wait for the outcome of the investigations before further comments.
