FDA by a letter 23.8.2021 states:

"We are issuing Department of Health and Human Services US License No 2229 to *BioNTech Manufacturing GmbH, Germany* under the provisions of section 351(a) of the PHS Act controlling the manufacture and sale of biological products. Under this licence, you are authorised to manufacture the product <u>COVID19 Vaccine</u> <u>mRNA...</u>"

<u>Note:</u> Absent the "marketing label" – COMIRNATY. The technical name for the vaccine is "COVID19 Vaccine mRNA"

For USA market ONLY

The said **Exhibit 3** continues to state:

"The review of this product was associated with the National Clinical Trials (NCT) numbers: <u>NCT04368728</u> and <u>NCT0430701.</u>"

Subject to very specific Clinical Trials (NCT)

4. <u>Exhibit 4 Clinical Guidelines On Covid19 Vaccination in Malaysia 2nd</u> and 3rd Editions (with 52 Annexures):

There are several contradictions, inconsistencies between this Exhibit 4 and the above Exhibits. You must download Exhibit 4 and do some homework. I will only furnish the same in Court or to any relevant authority investigating this mess. Heading of Letter

"<u>CONDITIONAL REGISTRATION OF COMIRNATY CONCENTRATE FOR</u> DISPERSION FOR INJECTION COVID-19 mRNA VACCINE WITH EU LABEL ON PRODUCT CARTON

First paragraph of letter:

"With regards to the matter above, Pfizer would like to inform that the label on the product carton is the <u>label approved by European Medicines</u> <u>Agency (EMA)</u>. During pandemic supply period, the approved label by EMA will be used for stocks supply to the rest of world including Malaysia."

EMA gave Conditional Marketing Authority (Exhibit 5) on 21.12.2020.

Then surely there is NO NEED for the scumbag, Chow Wan Lee, the Regulatory Affairs chap in Pfizer (Malaysia) Sdn Bhd in a letter dated <u>13.7.2021</u> to CHANGE THE LABEL on the cartons to that of the "EU Label on Product Carton" if at all material times, the so-called vaccines were imported from Europe and from BioNTech Manufacturing GmbH, Germany!!!
