

Going Behind The Voodoo Science

Step 1: A picture paints more than a thousand words

Now, examine the picture with a fine toothcomb! Don't rush and follow the red dotted lines!



I want you to focus on the words, "<u>Transmissible Vaccine</u>" and "Transferable Vaccine".

(a) <u>Transmissible Vaccine</u>

A <u>transmissible vaccine</u> is <u>administered directly</u> to one bat <u>via injection</u>. This bat (Red Outline) is then capable of vaccine transmission. In subsequent time steps (separated by the dashed red lines), this initial bat <u>encounters other animals</u> and <u>transmit the vaccine to them infectiously</u> (red bursts).

<u>Infectiously vaccinated bats also go on to transmit the vaccine infectiously to others.</u> Think! If it can be done to bats, then the method can be applied to ...?

(b) Transferable Vaccine

A <u>transferable vaccine</u> is <u>administered directly</u> to a focal bat <u>as a paste</u> to its fur. In subsequent time steps, <u>different bats groom</u> the fur of the focal bat and <u>become vaccinated</u>. The vaccine is <u>not contagious in the usual sense</u>; the focal bat <u>merely serves as a delivery vehicle</u> to the others.¹

Step 2 What is "Gain-of-Function" Research?

It will suffice for me to state here and now what is the meaning of **Gain-of- Function Research**:

"The term Gain-of-Function (GOF) research describes a type of research, that modifies a biological agent (e.g. bat virus) so that it confers new or enhanced activity to that agent. Ethical scientists use the term broadly to refer to any such modifications.

"In essence, GOF research <u>genetically alters an organism in a way that</u> may enhance the biological functions of gene products.

"This may include an altered <u>pathogenesis</u>, <u>transmissibility or host range</u> i.e. the types of host that a <u>microorganism</u> can infect."

Now, apply the above definition to the scenario of the bats explained in Step 1 above. The medical research on bats etc. and the data and results can have a "Gain-of-Function" when applied to the human scenario!

Step 3 The Human Scenario and Bioweapon Research (GOF)

The dual use of what is deemed an innocuous medical research to the more nefarious objectives by the Deep State, ends up as "weaponised research" in the development of inter-alia, biological weapons.

This was rampant during WWI and WWII as GOF research was used by both sides of the warring factions, with the victors (the so-called Allied Powers) demonising the vanguished Axis powers, mainly Germany and Japan and the hanging of the main actors. But for the medical and scientific professions, they were all spared, recruited into most advanced research institutions and paid handsomely. The Pirbright Institute in UK and Fort Dettrick, Maryland USA have their origins in such hideous collaborations with "spared" war criminals.

Biological weapons defined:

"Biological weapons is any <u>infectious agents</u> such as <u>Bacteria, Virus or toxins</u>, which is used <u>intentionally</u> to inflict bodily harm to people, animals or nature. They can be used to cause <u>massive casualties</u>, <u>social disruptions</u>, economic losses and <u>environmental</u> problems as a means of <u>warfare</u> or <u>terrorism</u>.

"Biological weapons are difficult to handle after release because they are <u>infectious agents</u> that <u>spread uncontrollably</u> beyond the <u>target area</u>."

So, WHAT DO YOU THINK IS COVID19?

Be very surprised. Besides my declaration in 2020, the only other person in the world as of today, who dare tell it as it is, is Dr. David Martin who recently in a video presentation uploaded to my website, called Covid19 as a bioweapon!

<u>Step 4</u> <u>The US National Institutes of Health (NIH) Confession On Potential Pandemic Pathogens (ePPP)</u>

The NIH confessed and we quote:

"<u>Potential Pandemic Pathogens (PPPs</u>) are bacteria, viruses and other microorganisms that are likely highly transmissible and capable of wide, uncontrollable spread in human populations and highly virulent, making them likely to cause significant morbidity and/or mortality in humans."

Additionally, the criminals at NIH admitted to Gain-of-Function (GOF) research, and we quote as follows:

"NIH has supported certain research that may be reasonably anticipated to create, transfer or use potential pandemic pathogens resulting from the enhancement of a pathogen's transmissibility and/or virulence in humans. The U.S. Government and the Department of Health and Human Services define such research as enhanced potential pandemic pathogen (ePPP) research. NIH-supported ePPP research requires strict oversight and may only be conducted with appropriate biosafety and biosecurity measures."

On funding issues, NIH stated:

"The HHS <u>Framework for Guiding Funding Decisions about Proposed Research Involving Enhanced Potential Pandemic Pathogens (HHS P3CO Framework)</u>... was established in 2017 to guide funding decisions on proposed research that is reasonably anticipated to create, transfer or use potential pandemic pathogens resulting from the enhancement of a pathogen's transmissibility and/or virulence in humans, called ePPP research.... For the third project, the HHS P3CO Review Group determined that a subset of the proposed research involving ePPPs was acceptable for funding with the implementation of additional risk mitigation measures."

In October, 2021, a letter addressed to Rep. James Comer (R-KY), NIH Principal Deputy Director Lawrence A. Tabak cites a "limited experiment" to determine whether "spike proteins from naturally occurring bat coronaviruses circulating in China were capable of binding to the human ACE2 receptor in a mouse model."

The US funded GOF research was blown wide open thanks to materials released through a Freedom of Information Act lawsuit by <u>The Intercept</u> against the National Institutes of Health, <u>revealing that EcoHealth was paid to make chimeric SARS-based Covid that they confirmed could infect human cells.</u>

Read the underlined words of the above quotation over and over again - Chimeric SARS-based Covid was made that could infect human cells!

Rutgers University Board of Governors Chermistry Professor Richard H. Ebrght, observed, "The NIH, specifically Colllins, Fauci and Tabak, lied to Congress, lied to the press, and to the public. Knowingly. Willfully. Brazenly."

Let it be stated here, that such GOF research was also conducted in Malaysia by "certain actors" in collaboration with Peter Daszak of the infamous Eco-Alliance, coordinated by a foreigner with over ten years of deep ties with the said Eco-Alliance. Determination of Public Health Emergency

SUPPLEMENTARY INFORMATION:

I. Background

<u>Under Section 564 of the FD&C Act, 21 U.S.C. 360bbb-3</u>, the Commissioner of the Food and Drug Administration (FDA), acting under delegated authority from the Secretary of HHS, may issue an Emergency Use Authorization (EUA) authorizing (1) the emergency use of an unapproved drug, an unapproved or uncleared device, or an unlicensed biological product; or (2) an unapproved use of an approved drug, approved or cleared device, or licensed biological product. Before an EUA may be issued, the Secretary of HHS <u>must declare that circumstances exist justifying the authorization based on one of four determinations:</u>

- (1) A determination by the Secretary of Homeland Security that there is a domestic emergency, or a significant potential for a domestic emergency, involving a heightened <u>risk of attack with</u> a, chemical, biological, radiological, or nuclear ("CBRN") agent or agents;
- (2) the identification of a material threat by the Secretary of Homeland Security pursuant to section 319F-2 of the Public Health Service (PHS) Act [1] sufficient to affect national security or the health and security of United States citizens living abroad;
- (3) a determination by the Secretary of Defense that there is a military emergency, or a significant potential for a military emergency, involving a heightened risk to United States military forces, including personnel operating under the authority of title 10 or title 50, of attack with (i) a biological, chemical, radiological, or nuclear agent or agents; or (ii) an agent or agents that may cause, or are otherwise associated with, an imminently lifethreatening and specific risk to United States military forces;

or (4) a determination by the Secretary that there is a public health emergency, or a significant potential for a public health emergency, that affects, or has a significant potential to affect, national security or the health and security of United States citizens living abroad, and that involves a CBRN agent or agents, or a disease or condition that may be attributable to such agent or agents. [2]

<u>Based on any of these four determinations</u>, the Secretary of HHS may then declare that circumstances exist that justify the EUA, at which point the FDA Commissioner may issue an EUA if the criteria for issuance of an authorization under section 564 of the FD&C Act are met.

The determination of a public health emergency, and the declaration that circumstances exist justifying emergency use of in vitro diagnostics for detection and/or diagnosis of the novel coronavirus (2019-nCoV) by the Secretary of HHS, as described below, enable the FDA Commissioner to issue EUAs for certain in vitro diagnostics for emergency use under section 564 of the FD&C Act. The Centers for Disease Control and Prevention (CDC) requested that the FDA issue an EUA for it, in Start Printed Page 7317 vitro diagnostic for detection of 2019-nCoV to allow the Department to take preparedness measures based on information currently available about 2019-nCoV.

Since reference is made of section 564 of the FD & C Act in the above document, as well as FDA official documents such as to Pfizer, Moderna etc., in granting Emergency Use Authorisation (EUA), I shall refer to a specific extract of one such document, namely:



Pfizer Inc. Attention: Ms. Elisa Harkins 500 Arcola Road Collegeville, PA 19426

Dear Ms. Harkins:

On February 4, 2020, pursuant to Section 564(b)(1)(C) of the Act, the Secretary of the Department of Health and Human Services (HHS) determined that there is a public health emergency that has a significant potential to affect national security or the health and security of United States citizens living abroad, and that involves the virus that causes Coronavirus Disease 2019 (COVID-19).1 On the basis of such determination, the Secretary of HHS on March 27, 2020, declared that circumstances exist justifying the authorization of emergency use of drugs and biological products during the COVID-19 pandemic, pursuant to Section 564 of the Federal Food, Drug, and Cosmetic Act (the FD&C Act or the Act) (21 U.S.C. 360bbb-3), subject to terms of any authorization issued under that section.

We now refer to the relevant provisions of the FDA Act as referred to in the above letter and annotated as (FDA 360bbb-3). Google this reference or you will be in the wilderness.

Section (b) Declaration of Emergency

(1) In General

- The Secretary may declare an emergency justifying the authorisation under this sub-section for a product on the basis of –
- (C) a determination by the Secretary of a public health emergency under section 247d of title 42 that affects, or has significant potential to affect, national security, and that involves a specified biological, chemical, radiological or nuclear agent or agents or a specified disease or condition that may be attributable to such agent or agents.

Additionally I will also refer to the **Pandemic and All Hazards Preparedness Reauthorization Act 2013** to buttress the point that CBRN threats were the basis of the Declaration of Emergency in the USA.



Pandemic and All-Hazards Preparedness Reauthorization Act of 2013 (PAHPRA)

"The Pandemic and All-Hazards Preparedness Reauthorization Act of 2013 (PAHPRA) contains key legal authorities to sustain and strengthen our Nation's preparedness for public health emergencies involving chemical, biological, radiological, and nuclear (CBRN) agents, as well as emerging infectious disease threats."

"Together, these authorities for FDA not only support and facilitate government partners' pre-event planning efforts and pre-positioning of MCMs, but also help to facilitate MCM development and the efficient and rapid deployment of these medical products in the event of a CBRN emergency or emerging disease health threat. FDA is implementing PAHPRA's MCM-related provisions to support our nation's preparedness and response capabilities, and continues to provide the highest quality and most timely guidance possible to all stakeholders engaged in MCM product development."

Please note that <u>MCM</u> refers to **Medical Counter Measures** for your information.

<u>Step 5 No Country will Unleash a Bioweapon without the safety net of an Antidote</u>

Go back to <u>Step 1</u>. It is obvious that vaccines are NOT the antidote. Only the Deep State and its actors have the antidote <u>as they are the ones who created</u> the bioweapon and the antidote.


