OPEN LETTER TO OUR

YANG di-PERTUAN AGONG (COMMANDER-IN-CHIEF)

WHEREAS:

- (1) The Zionist Talmudists through the their spoke-person, the Prime Minister of Israel, Benjamin Netanyahu have openly and unreservedly declared that they will unleash a genocidal campaign to destroy Gaza and wipe out the Palestinians living in Gaza, the world's largest open-air prison;
- (2) Under International Law, the actions of the Zionist Talmudists in Israel constitute war crimes and by an Advisory Opinion of the International Court Of Justice (ICJ) on July 2004, Israel cannot claim a "Right of self Defence" to justify their actions, because this claim cannot accrue to Israel, as Israel is a state that has occupied Palestine since 1948 and has mounted a blockade, to deprive and deny the Palestinians to live with dignity as humans.
- (3) The Court determines the rules and principles of international law which are relevant to the question posed by the General Assembly. The Court begins by citing, with reference to Article 2, paragraph 4, of the United Nations Charter and to General Assembly resolution 2625 (XXV), the <u>principles of the prohibition</u> of the threat or use of force and the illegality of any territorial

acquisition by such means, as reflected in customary It further international law. cites the principle of selfdetermination of peoples, as enshrined in the Charter and reaffirmed by resolution 2625 (XXV). As regards international humanitarian law, the Court refers to the provisions of the Hague Regulation of 1907, which have become part of customary law, as well as the Fourth Geneva Convention relative to the Protection of Civilian Persons in Time of War of 1949, applicable in those Palestinian territories which before the armed conflict of 1967 lay to the east of the 1949 Armistice demarcation line (or "Green Line") and were occupied by Israel during that conflict. The Court further notes that certain human rights instruments (International Covenant on Civil and Political Rights. International Covenant on Economic, Social and Cultural Rights and the United Nations Convention on the Rights of the Child) are applicable in the occupied Palestinian territory.

- (4) The Court further finds that <u>it is for all States</u>, while respecting the United Nations Charter and international law, <u>to see to it that any impediment</u> in the exercise by the Palestinian people of its right to self-determination <u>is brought to an end.</u> <u>In addition, all States parties to the Fourth Geneva Convention are under an obligation, while respecting the Charter and international law, to ensure compliance by Israel with international humanitarian law as embodied in that Convention.</u>
- (5) The United States of America has openly condone the genocidal actions of Israel and sent three aircraft carrier battle groups to threaten neighbouring nations from intervening to stop the illegal actions of Israel as required to do so by international law.

Given the five paragraphs in the above preamble, and the wanton slaughter of Palestinians in Gaza, amounting to over 10,000 men, women and children, the destruction of hospitals and medical facilities, Malaysia cannot sit on the fence with mere demonstrations, press conferences and the issuance of statements condemning the atrocities inflicted on the Palestinians by Zionist Talmudists.

I therefore seek the indulgence of the Yang di-Pertuan Agong, as Commander-In-Chief and our Prime Minister to assist my

efforts in establishing a volunteer fighting force – The "Phoenix Brigade" and as well as a volunteer force "The Spirit of Rachel Corrie" in bringing humanitarian and medical aid to the heroic people of Gaza. Rachel Corrie was mowed down and murdered by a soldier driving a bulldozer, while she resisted the demolition of a Palestinian home.

I pray and I hope that the Royal Malaysian Navy will escort a flotilla to deliver the fighting force and aid to Gaza and for that purpose I hereby volunteer to lead such an effort, if I am considered worthy of that high honour - Inshallah!

Malaysians cannot fail the people of Palestine. We must stand and be counted until total victory over the fascist Zionist Talmudists.
