# Government leaders Are Not Elected But Selected. \$\$\$ Billions Are Given To The "Chosen" Political Parties, And The Leaders Will Do As Directed! By Matthias Chang

Please, please don't believe me. However, you may want to investigate and check out what I have disclosed. I am not trying to persuade you, but I am merely disclosing facts which you may want to verify.

### Second Passage:

"Neoliberalism means 'dismantle the whole edifice of government and replace it with what they called the free market'.... Neoliberalism means centralised planning shifted away from Washington and other political capital into the financial centres, away from Washington to Wall Street .... and The City of London.... And in other countries away from industries

towards International banking... To them a 'Free market' is a market where wealthy people are free to do whatever they want ... and to exploit without any government interference with their extraction and predatory behaviour..."

# Third Passage:

"The campaign donors decide which politicians will have the money to buy TV time and essentially the pay in the Democratic Party, the Democratic National Committee. The Democrats appoint the Heads of every government committee by how much money can you contribute to the Democratic National Committee, which is a group of ultra-right wing rentiers, very much the same people who finance the Republican Party.

"They are the same party basically... They contribute to make sure ... the FIRE sector: finance, insurance, real estate, along with monopolies in the military.... That's the core of the campaign contributors who dominate both the Republican and Democratic Parties, but most blatantly the Democrats..."

Although Prof. Michael Hudson was writing about the USA, he did state "in other countries" the same reality applies.
