An Appeal – Stop The Genocide of Palestinians in Gaza.

Prologue

This is not a Letter to the King of Malaysia per se but an Appeal to his Majesty via your support for this Appeal that the massive killing of Palestinians (in total contravention of all International and Domestic Laws and Conventions ratified by all nations, who are members of the United Nations), have not ceased, but intensified and MUST be STOPPED!

The <u>political leaders in Malaysia</u> have let us down, especially the Palestinians because these political leaders do not have the courage of our convictions to initiate a <u>regional</u>, <u>long lasting effort</u> to ensure that no genocide can be implemented in Palestine now and in the future, and that the Zionist Anglo-American terror must be exposed completely because <u>it is these Zionist war criminals that are establishing</u>, <u>funding</u> and <u>training</u> <u>brainwashed</u> and <u>misguided</u> <u>Muslim</u> brothers and sisters to be cannon fodders for the agendas of this Zionist cabal of criminals (ISIS, AI QAEDA ETC).

This effort must start first in Malaysia, then the entire ASEAN region and through the good offices of the <u>Heads of State</u> of these countries, a global initiative can be mounted to <u>outlaw and criminalise</u> the propaganda and lies by global main Stream Media that a people - innocent men, women and children can be slaughtered with impunity because they are not humans at all.

Zionists throughout the world and Israelis were brainwashed by their <u>Talmudic</u> <u>teachings</u> that only Talmudists and Israelis are humans and the massacre and murder of all other peoples are justified via ethnic cleansing AND MASS SLAUGHTER.

All wars must first be waged via an intense propaganda campaign to justify a war to be unleashed and supported by the people.

Without first winning the propaganda war, no wars can be supported by the people.

The Rationale

Politicians are basically self-interested and ego centred individuals addicted to power, the most heinous addiction, worse than drug addiction. Politicians have failed us by their sordid connivance and collaboration with global vested interests. All political leaders are <u>"groomed and selected"</u> and <u>"not elected</u>" as elections are the covers to legitimise political power. Look no further than in USA and UK where elections are rigged openly – votes are falsified, votes are transferred from one candidate to the "selected" candidate. And they are touted to be the shining examples of "Democracy".

The **Heads of State** in the overall game of politics is a different matter. <u>It is not the</u> <u>perfect solution</u> but it is the Last Card that the people in Malaysia can utilise to effect change. We need not go further, than to adhere to and implement the Constitutional Provisions as enacted in Malaysia.

The Federal Constitution of Malaysia

The Federal Constitution has been misinterpreted over the years by vested political interests to enhance the role of politicians and downgrade the role of the Head of State.

Don't believe me, please examine the provisions of the Constitution with a fine toothcomb. You have been thoroughly brainwashed!

Article 4

The Constitution is the **Supreme Law of the Federation**. Any law passed after Merdeka day which is inconsistent with this Constitution shall, to the extent of the inconsistency be void.

Article 32

There shall be a **Supreme Head of the Federation**, to be called the **Yang Di-Petuan Agong**, who shall take precedence over all persons in the Federation and shall not be liable in any proceedings whatsoever in any court **except in the Special Court established under Part XV.**

Is this exception of the "Special Court" void as being inconsistent with the principle of "Sovereign Immunity"? When a State has absolute Sovereign Immunity, which is personified by the King /Sovereign, how can this exception not be in contravention and or inconsistent with the Constitution?

Article 34

We shall highlight <u>only some</u> of the provisions which will surprise you!

- (2) The Yang D-Pertuan Agong shall not hold any appointment carrying any remuneration.
- (3) The Yang Di-Pertuan Agong shall not actively engage in any commercial enterprise.
- (6) Clauses (2) and (3) shall also apply to the Raja Permaisuri Agong.

Article 39

You are most likely unaware of this provision.

The **executive authority** of the Federation shall be **vested in the Yang Di-Pertuan Agong** and exercisable, subject to the provisions of any federal law and of the Second Schedule, by him or by the Cabinet or any Minister authorised by the Cabinet, but Parliament may by law confer executive functions on other persons.

The Yang Di-Pertuan Agong by the above definition cannot be and is not a rubber stamp to be bullied or pressurised by politicians.

Article 40

In the exercise of his functions under this Constitution or Federal Law the Yang Di-Pertuan Agong <u>shall act</u> in accordance with the advice of the Cabinet or of a Minister acting under the general authority of the cabinet, <u>except as provided by</u> <u>this Constitution</u>; and <u>shall be entitled</u>, at his request, to any information concerning the government of the federation which is available to the Cabinet.

This means that in certain situations, as provided in the Constitution, the Yang Di-Pertuan <u>NEED NOT FOLLOW</u> the advice of the cabinet etc. He has a discretion to act in accordance with his judgment.

Article 41

This is very important and most relevant to our discussion.

The Yang Di-Pertuan Agong **SHALL be the Supreme Commander** of the armed forces of the Federation.

This means that the word "**shall**" only apply to the King and no one else. Not even the Prime Minister.

Article 44

The legislative authority of the Federation <u>SHALL</u> be <u>VESTED</u> in a Parliament which <u>SHALL consist</u> of the <u>Yang Di-Pertuan Agong</u>, and <u>two Majlis</u> (Houses of Parliament) to be known as the Dewan Negara (Senate) and the Dewan Rakyat (Hoise of representatives).

This is one of the most misunderstood provision and **MANIPULATED** in regard to the stature of the Yang Di-Pertua Agong. He is not a Puppet and or a Rubber Stamp.

The King is an essential part and **ONE of the three pillars** of Parliament. He is not there just for the Opening of Parliament.

Article 55

The Yang Di-Pertuan Agong **SHALL** from time to time **summon Parliament** and shall not allow six months to elapse between the first sitting in one session and the date appointed for its first meeting in the next session.

The Yang Di-Pertuan Agong <u>MAY</u> prorogue or dissolve parliament.

The PM or the Cabinet has no say. The discretion lies with the King!

The relevance of the above Constitutional Provisions

For the purposes of this discussion, and since Islam is the religion of the Federation, the entire nation must be called upon to protect against the slaughter and murder of fellow Muslims brothers and sisters, presently in Gaza by the Zionist Anglo-American war criminals.

When a small country such as Yemen was attacked for almost a decade by war criminals of the Zionist Anglo-American Cabal, and is now in the front lines defending Gaza by inter-alia blockading the Red Sea and stopping all ships that transport goods to Israel, Malaysia with a much larger population and resources must do more.

We have gone past the need or the initiative to have an <u>"Aid Flotilla"</u> as we had done in the past via the Rachel Corrie and the Spirit of Rachel Corrie (renamed MV Finch) to mislead the Zionists, so as to breach the Israel imposed the then blockade of Gaza.

There is now a genocide and not a blockade per se!

And the Palestinian Authority in the West Bank, in cahoots with the Zionist Israelis are allowing and committing this mass murder.

We seek the Yang Di-Pertuan Agong's (Agong) indulgence as the Supreme Commander to send the Malaysian Royal Navy to escort Malaysian volunteers to arrive safely in Yemen and in Iran to help in the Resistance TO FIGHT AGAINST THIS BARBARIC MASS MURDER.

Malaysians of all Faiths must help our brothers and sisters In Gaza beyond sending aid, which the US and Israel are stopping from getting through to the brave people of Gaza. These criminal bastards are even bombing aid convoys from reaching Gaza via the Rafah Crossing!

This is a Just War and if we are to defend Islam and or Allah as some politicians are saying, and they have even the bravado to say that they are willing to die to defend Allah, than they must lead by example.
