".... the moral, material, cultural and intellectual decay that we are witnessing helplessly every day across the globe, <u>is not accidental</u>, not an act of God who is punishing us for our earthly misdeeds, <u>but a deliberately induced social crisis</u>.

"This evil consists of some of the world's prestigious centres of knowledge and research such as Stanford Research Centre at Stanford University, Rand Corporation, MIT / Sloane, the Advanced Centre of Behavoural Sciences at Palo Alto, the Institute of Social Research at the University of Michigan, the Wharton School of Business, the Harvard Business School, London School of Business, the Hudson Institute, the Office of Naval Research etc."

The primary target is the United States and thereafter the Global World Order.

And Malaysia would not be spared!

Why?

Daniel Estulin warned,

"Every aspect of the mental and psychological life of people on the planet was profiled, recorded and stored in computer systems. Above the closely cooperating groups of social scientists, psychologists, psychiatrists, anthropologists, think tanks and foundations presides the elite of powerful members of the oligarchy comprised mostly of the old Venetian Black Nobility ...

"Psychological terror is not the essence, but the punctuation mark of the new totalitarianism's meaning... Wall Street prescribed market failures to provide for societies are instead punishing these societies for alleged sins against market laws ... the victims are blamed for their new deprivation, misery and oppression. This is far more effective mode of rule than jackboot terror which is more overt, but it exposes the system to another form of resistance ... We are at the cross roads. And the roads we take will now terminate whether we will live in the 21st century as a nation state, republics or a subjugated, culled and dehumanised crop of slaves ..."

John Marks in exposing the medical profession in this dastardly crime recalled how a doctor working for the CIA told a classroom of recruits,

"Our guiding light is not the Hippocratic Oath but the victory of Freedom."

The Intel Operatives are of two minds about the practice of secret intelligence – ready enough to admit we've got to do it, but unhappy with the way it's so often done.

John Marks observed further that,

"Like all embarrassments, the CIA's secret drug-testing program began prosaically – with the bright idea that 'science' might be used to solve certain nagging difficulties of the intelligence business. The principal secret of secret intelligence is how to get someone to do your bidding. Money, sex, fear and the desire for revenge all work, but none perfectly or dependably. <u>Ideological conviction is probably the best of all, but it's also the rarest.</u> Holding on to spies once they've been recruited is just as difficult. They get cold feet, get greedy, get hurt feelings or get ideas of their own. One way or another, they slip away. When old hands in the game talk about intelligence tradecraft, a favourite subject, <u>they talk about two things – how to conduct operations, without attracting notice, and how to recruit and manage agents.</u>"

This is not a lengthy analysis or a thesis but a short summary of the evil agenda of the Black Hats in the Global Intel Apparatus. Therefore, I will cite a few examples to buttress my conclusions.

The United States ended 20 years of war in Afghanistan — the longest war in American history (2001 to 2021), costing \$2.26 Trillion and spanning four Presidencies. Did you know that this war has nothing to do with September 11, 2001 (9/11)? There is no way for the US to start a war less than a month from 9/11.

The war was planned BEFORE 9/11 as the decision was made in July of 2001 to attack Afghanistan. It has to do with oil, specifically an oil pipeline, after the TALIBAN awarded a contract for the transport of oil and gas from the Caspian Sea to an Argentinian company, Bridas Corporation.

As far back as 1997, Dick Cheney who was running Halliburton and he had secured a contact for oil exploration and drilling in the Caspian Sea.

In June 2001, Secretary of State, Colin Powell made an announcement that the US would make a gift of \$43 Million to the Taliban. However, the Taliban leaked information that the Bush supported by the Intel Apparatus would launch a military operation in July and an attack would occur in the summer of 2001. Following the invasion (delayed till Sept.) the US cancelled the Bridas contract.

It has also been revealed by a Pakistani diplomat to the BBC that,

"I was told by senior American officials in <u>mid-July</u> that military action against Afghanistan would go ahead by the middle of October."

Andrew Marshall in "Origins of the Afghan War, Geopolitical Monitor" wrote,

"The war on Afghanistan was launched on October 7, 2001. An operation of this size could not be planned and executed within three weeks, as we are led to believe. The plans and preparations were in place in the year leading up to the invasion..... The result of this war on Afghanistan is that Afghanistan's opium production reaches record level every single year, and as of April 2008, a US-sponsored pipeline agreement was signed with Turkmenistan, Afghanistan, Pakistan and India, and may have Canadian forces in Afghanistan guarding the pipeline route. Mission Accomplished."

Additionally, the war in Afghanistan was to secure the lucrative drug trade, which resulted in \$Billions in profits, laundered through the global financial system. Contrary to the Western propaganda, the Taliban was never behind this heinous drug trade. It was the US, its Intel Apparatus that controlled this evil.

I will now quote William Van Wagenan's article "How the Taliban Crushed the CIA's Heroin Bonanza in Afghanistan":

"It comes as a surprise then, that a June 2023 <u>report</u> published by Alcis, a British-based geographic information services firm, revealed that the Taliban government <u>had all but eliminated opium cultivation in the country, wiping out the base ingredient needed to produce heroin. This outcome mirrored a similar move by the Taliban in 2000 when they were in power for the first time.</u>

"Ironically, instead of praising Kabul's new leaders for quashing the source of illicit drugs, the international community responded to this development with criticism. Even the US Institute for Peace (USIP), which is funded by the US government, argued that "The Taliban's successful opium ban is bad for Afghans and the world.

"Such western displeasure towards the Taliban's efforts to dismantle the global heroin trade may seem perplexing at first glance. However, a closer examination of events in Afghanistan reveals a different perspective. Under the guise of the 'War on Terror,' the 2001 US and UK invasion was <u>driven in part by the desire to restore the heroin trade, which the Taliban had abruptly terminated just a year earlier.</u>

"The western powers sought to <u>re-establish</u> the lucrative flow of billions of dollars that the heroin trade provided to their financial systems. <u>In fact, 'For 20 years, America essentially ran a narco-state in Afghanistan'..."</u>

The role of the rogue CIA in the heroin trade:

"To understand the origins of the Afghan heroin trade, a review of US involvement in the central Asian nation is necessary, beginning in 1979 when the <u>CIA embarked on a covert program</u> to undermine the pro-Soviet Afghan government in Kabul.

"The US covertly supported an umbrella of Muslim guerrilla fighters known as mujahideen, with the hope that provoking an insurgency would entice the Soviet Army to intervene. This calculated move would force the Soviets into occupying Afghanistan and engaging in a protracted and costly counter-insurgency

campaign, thereby weakening the Soviet Union over time. To accomplish this, the CIA turned to its close allies, Saudi Arabia and Pakistan, for help. Saudi Prince Bandar bin Sultan facilitated a meeting between CIA Director William Casey and Saudi King Fahd, in which the Saudis committed to matching "America dollar for dollar supporting the mujahedeen. The US and Saudi Arabia, with help from Pakistani's Inter-Services Intelligence (ISI), set up training camps for the mujahideen in Pakistan, and supplied them with advisors, weapons, and cash to fight the Soviets.

"Gulbaddin Hekmatyar, the founder of the Hizb-i-Islami militia, was among the most prominent mujahideen leaders, receiving some \$600 million in aid from the CIA and its allies. Journalist Steve Coll <u>writes</u> in his Pulitzer Prize-winning book Ghost Wars that Hekymatyar recruited from the most radical, anti-western, transnational Islamist networks to fight with him, including Osama bin Laden and other Arab volunteers. <u>CIA officers 'embraced Hekmatyar as their most dependable and effective ally,' and 'the most efficient' at killing Soviets.</u>

"1979 and 1980, just as the CIA effort was beginning to ramp up, a network of heroin laboratories opened along the Afghan-Pakistan frontier. That region soon became the world's largest heroin producer. The process involved smuggling raw opium gum to Pakistan, where it was processed into heroin in laboratories run by the ISI. The finished product was then discreetly transported via Pakistani airports, ports, or overland routes.

"By 1984, Afghan heroin supplied a <u>staggering 60 per ent of the US market and 80 percent of the European market</u>, while devastatingly creating 1.3 million heroin addicts in Pakistan, a country previously untouched by the highly-addictive drug.

"McCoy states further that, "caravans carrying CIA arms into that region for the resistance often returned to Pakistan loaded down with opium." Reports from 2001 cited by the New York Times confirmed that this occurred 'with the assent of Pakistani or American intelligence officers' who supported the resistance."

Need I say more???

The above case study is sufficient to conclude that the Black Hats of the Global Intel Apparatus (mainly CIA and British Intel Services) sought to <u>re-establish</u> the lucrative <u>flow of billions of dollars that the heroin trade provided to their financial systems.</u>

In fact, for 20 years, America essentially ran a narco-state in Afghanistan!

We will now focus on the **Brits and their dastardly role in the cultivation and spread of heroin.**

I will quote William Van Wagenan again:

"In September 2010, eight months after the start of the surge ... reports emerged that British soldiers were involved in trafficking heroin out of Afghanistan using military aircraft at airports in <u>Camp Bastion</u> and Kandahar. Camp Bastion, <u>jointly operated by the UK and the US</u>, was located near Lashkar Gah, another major centre of poppy cultivation. In 2012, it was alleged that poppy cultivation was

taking place just outside the base's perimeter, with British soldiers providing protection to farmers against Afghan security forces.

"By late 2014, British and US forces withdrew from Camp Bastion, handing it over to Afghan forces, who renamed it Camp Shorabak. However, according to a UN report, 'the opium-growing area around Britain's main base in Afghanistan nearly quadrupled between 2011 and 2013.' Despite the withdrawal, opium exports from Camp Shorabak apparently continued, and a small number of British military personnel returned in 2015 in what was described by the Ministry of Defense as an advisory role.

"In 2016, Obaidullah Barakzai, a member of the National Assembly of Afghanistan, <u>claimed</u>, 'It's impossible for a few local drug smugglers to transfer opium in thousands of kilos. <u>This is the work of the Americans and British</u>. They transport it by air from Camp Shorabak.

"After US forces chaotically withdrew from Afghanistan in August 2021, the Taliban once again succeeded in eliminating poppy cultivation, showing it was far from a dedicated drug cartel after all."

Another independent and an impeccable source is Peter Dale Scott who observed that according to the UN, some \$352 billion in drug profits had been absorbed into the western financial system, including through the US' largest banks in 2009.

The "United States involvement in the international drug traffic links the CIA, major financial interests, and criminal interests in this country and abroad.

Global too Big To Fail Banks are up to their eyeballs. Leading the pack is the HSBC, Britain's biggest bank, who historically was involved in the Opium Trade to China!

To many of you reading this article, this exposé may come as a surprise. This is to be expected because you read fake news and propaganda spurned by the global mass media.
