### Why is England called the Court of St. James?

***St James's Palace is the most senior royal palace in London, the capital of the United Kingdom. The palace gives its name to the Court of St James's, which is the monarch's royal court, and is located in the City of Westminster in London.***



***The Court of St James's serves as the official royal court for the Sovereign of the United Kingdom. The Court formally receives all ambassadors accredited to the***

United Kingdom. Likewise, ambassadors representing the United Kingdom are formally accredited from this court. The Marshal of the Diplomatic Corps, known as Master of the Ceremonies before 1920, serves as the liaison between the British monarch and foreign diplomatic missions. The Marshal is stationed permanently at St James's Palace.

Charles was officially proclaimed King on the Saturday following the Queen's death. This event took place at St James's Palace in London, in front of a ceremonial body known as the Accession Council.

## Essence of All Imperial / Colonial Wars

## WW I

- **WWI** was a fight to the death by the global political crime families to have absolute control of the European real estate and the colonies!

- It was only on April 6, 1917 **the United States formally declared war against Germany and entered the conflict in Europe.**
- Though the Allied faction 'won' at great costs to the Allied political crime families, it was not conclusive and or decisive in resolving the issue, ***who would be the "Supreme Unipolar Power?"*** But, the Allied powers got the jackpot in the Middle East Real Estate and the Oil spigots!

## WW II

- There was a tacit secret agreement between the Court of St. James ("Great Britain") and the "United States" that Germany **must be**

**incentivised** to fight to the **last German** to destroy the Soviet Union to enable the Court of St. James to control the world.

- The Mackinder theory was the bait - **whoever controlled Eastern Europe –the Heartland—would control the world. - The tide of WWII turned with the Soviet victory at the **Battle of Stalingrad** (February 1943). The destruction of two entire German armies marked the beginning of the end of the Nazis and the Third Reich.
- WWII ensured that USA will be the ultimate Supreme Power of the Allied Powers, and following WWII and the collapse of the Soviet Union in 1991, the US became the Uni-Polar power (sole superpower) of the world.
- Post WWII, Germany and Japan became the cannon-fodders for the US in Europe and Asia respectively.

It is not necessary to explain how the US became the “undisputed financial power” of the world if we accept the conventional wisdom on geopolitics.

**However, I will invite you to consider that the “Court of St. James” is the “Hidden and Ultimate Power (via certain families)!**
