Initially, it covered Japan (including annexed Korea), Manchukuo, and China, but as the Pacific War progressed, it also included territories in Southeast Asia. The term was first coined by Minister for Foreign Affairs Hachirō Arita on June 29, 1940.

The proposed objectives of this union were to ensure economic self-sufficiency and cooperation among the member states ... In reality, militarists and nationalists saw it as an effective propaganda tool to enforce Japanese hegemony. The latter approach was reflected in a document released by Japan's Ministry of Health and Welfare, An Investigation of Global Policy with the Yamato Race as Nucleus (1), which promoted racial supremacist theories. Japanese spokesmen openly described the Great East Asia Co-Prosperity Sphere as a device for the "development of the Japanese race."

I do not admit that a wrong has been done to those people by the fact that a stronger race, a higher grade race, or at any rate, a more worldly-wise race, to put it that way, has come in and taken their place.'

Gilbert relates Churchill's advocacy for replacing Arabs with Jews as the majority in Palestine at the Peel Commission in 1936.

Professor Reginald Coupland "complained that the Jewish Agency ... had its representatives in London 'and they can speak to the Colonial Office and the Arabs feel on their side they are rather left in the cold. They have not the great engine the Jews have.' <u>Churchill replied brusquely, not hiding his preference: 'It is a question of which civilisation you prefer.'</u> (2)

On August 14, 1997, shortly after the Thai baht collapsed on July 2<sup>nd</sup>, Indonesia floated the rupiah. This <u>prompted Stanley Fischer</u>, then the Deputy Managing Director of the International Monetary Fund and presently Vice Chairman of the U.S. Federal Reserve, to proclaim that "the management of the IMF welcomes the timely decision of the Indonesian authorities. The floating of the rupiah, in combination with Indonesia's strong fundamentals, supported by prudent fiscal and monetary policies, will allow its economy to continue its impressive economic performance of the last several years."

Contrary to the IMF's expectations, the rupiah did not float on a sea of tranquility. It plunged from a value of 2,700 rupiahs per U.S. dollar to lows of nearly 16,000 rupiahs per U.S. dollar in 1998. Indonesia was caught up in the maelstrom of the Asian Financial Crisis.

By late January 1998, President Suharto realized that the IMF medicine was not working and sought a second opinion. In February, I was invited to offer that opinion and was appointed as Suharto's Special Counselor. Although I did not have any opinions on the Suharto government, I did have definite ones on the matter at hand. After nightly discussions at the President's private residence, I proposed an antidote: an orthodox currency board in which the rupiah would be fully convertible into and backed by the U.S. dollar at a fixed exchange rate. On the day that news hit the street, the rupiah soared by 28% against the U.S. dollar on both the spot and one year forward markets. These developments infuriated the U.S. government and the IMF.....

Ruthless attacks on the currency board idea and the Special Counselor ensued. Suharto was told in no uncertain terms - by both the President of the United States, Bill Clinton, and the Managing Director of the IMF,

# <u>Michel Camdessus - that he would have to drop the currency board idea</u> or forego \$43 billion in foreign assistance.

When Mrs. Hanke and I were in residence at the Shangri-La Hotel in Jakarta, the Clinton administration's objection to the currency board was "not that it wouldn't work, but that it would, and if it worked, they would be stuck with Suharto."

Much the same argument was articulated by Australia's former Prime Minister Paul Keating: "The United States Treasury quite deliberately used the economic collapse as a means of bringing about the ouster of Suharto." Former U.S. Secretary of State Lawrence Eagleburger weighed in with a similar diagnosis: "We were fairly clever in that we supported the IMF as it overthrew (Suharto). Whether that was a wise way to proceed is another question. I'm not saying Mr. Suharto should have stayed, but I kind of wish he had left on terms other than because the IMF pushed him out." Even Michel Camdessus could not find fault with these assessments. On the occasion of his retirement, he proudly proclaimed: "We created the conditions that obliged President Suharto to leave his job."

This can never happened in Indonesia again. No way!

- KUALA LUMPUR, April 30 -- Malaysia's official reserve assets amounted to US\$113.76 billion (US\$1=RM4. 76) as of end-March, 2024, while other foreign currency assets stood at US\$1.61 billion, according to Bank Negara Malaysia (BNM).
- Malaysia has gold reserves, increasing 6.84 per cent to 38.88 tonnes from 36.39 tonnes, according to City Index using data from the World Gold Council.
- Singapore's gold reserves had recently increased by 30 per cent in January 2023, City Index said Singapore had the third-largest increase in gold reserves in the last decade, increasing by 20.68 per cent from 127.4 to 153.74 tonnes.
- Although Malaysia was considered to be the most similar country to Singapore by several metrics, Malaysia's gold reserves had increased by just 6.84 per cent in the same period, a difference of 13.84 percentage points.
- Thailand has had the second-largest increase in gold reserves in the last decade, increasing by 60.20 per cent from 152.41 to 244.16 tonnes.
