The million slaughtered by chemical warfare. "....there has been several international agreements attempting to limit and ultimately abolish chemical warfare. The Brussels Declaration in 1874 (un-ratified) forbade parties 'to employ poison or poisoned arms.' The Hague Conference signed in 1899 (entered into force in 1900 and updated in 1907) forbade the "use of projectiles the object of which is the diffusion of asphyxiating or deleterious gases." The Geneva Protocol signed in 1925 (entered into force in 1928) forbade "the use in war of asphyxiating, poisonous or other gases, and of all analogous liquids, materials or devices." Most recently the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and their Destruction of 1993 (entered into force in 1997) is administered by the Organisation for the Prohibition of Chemical Weapons (OPCW). This Chemical Weapons Convention has been ratified by all member states of the United Nations, with certain exceptions..."

Case Study:

The U.S. Military and the Herbicide Program in Vietnam

From 1962 to 1971, the U.S. Air Force sprayed nearly 19 million gallons of herbicides in Vietnam, of which at least 11 million gallons was Agent Orange, in a military project called Operation Ranch Hand. An additional quantity (1.6 million gallons has been documented) of herbicides was applied to base perimeters, roadways, and communication lines by helicopter and surface sprayings from riverboats, trucks, or backpacks. Herbicide operations in Vietnam had two primary military objectives: (1) defoliation of trees and plants to improve observation, and (2) destruction of enemy crops.
