Scholarly curation of literary texts began in around 2500 BC. The later kingdoms and empires of the ancient Near East had long traditions of book collecting. The ancient Hittites and Assyrians had massive archives containing records written in many different languages. The most famous library of the ancient Near East was the **Library of Ashurbanipal** in Nineveh, founded in the seventh century BC by the Assyrian King Ashurbanipal (ruled 668–c. 627 BC). A large library also existed in **Babylon** during the reign of **Nebuchadnezzar II** (c. 605–c. 562 BC). Libraries enhanced a city's prestige, attracted scholars, and provided practical assistance in ruling and governing the kingdom. Egypt was the ideal habitat for the papyrus plant, which provided an abundant supply of materials needed to amass their knowledge repository."

The Alexandria Library is not the first library in the world.

The distinction goes to the **Library of Ashurbanipal**. It is the world's oldest known library and was founded sometime in the 7th century B.C. for the "royal contemplation" of the Assyrian ruler Ashurbanipal. **Located in Nineveh in modern-day Iraq, the site included a trove of some 30,000 cuneiform tablets organized according to subject matter.**

The Geneva Bible is one of the most historically significant translations of the Bible into English, preceding the Douay Rheims Bible by 22 years, and the King James Version by 51 years.

The King James Version of the Bible was not the first English language version of the Bible, but the culmination of extensive translation activity in the 1500s. This began with the work of William Tyndale and the printing of the first English New Testament in **1526**.

However, during the colonial times and thereafter, King James Version (KJV), English translation of the Bible, published in 1611 under the auspices of King James I of England, was accepted as the "standard" English Bible from the mid-17th to the early 20th century.

No Christians, and for that matter historians have asked,
