

Trump Regime's 'Epstein Files' Coverup Implicates Pedo-Trump More Than Ever

Trump's [Synagogue of Satan](#) administration's overt avoidance to release the promised Epstein files after being stalled for months blew up this week as a complete whitewash of denial. The second term president already in his first six months has broken a slew of campaign promises, so really no one should be all that surprised when on July 6th his DoJ and FBI leaked their volatile memo to [Axios](#) as if no one would even notice. Did Zionist Trump and his [Zionist](#) Attorney General Pam Bondi actually believe dropping their bombshell claiming no evidence exists of an Epstein client list protecting blackmailed VIP pervs, or that Epstein never ran an intelligence operation, or that his supposed death was not by suicide? No one believes these Trump administration coverup lies.

Without facing the American public directly with a press conference announcing their Epstein findings knowing it [betrays](#) the MAGA faithful, Trump and his sniveling Department of Justice and FBI instead cowardly chose to leak their false bombshell that totally contradicts the mountains of evidence that Epstein and partner-in-crime Ghislaine Maxwell ran an intel blackmail operation for Mossad, CIA and MI6 for at least two full decades. This article completely exposes this in-our-face deception by Trump et al, totally denying that American history's most infamous pedophile was never guilty of coercing minors into lurid sex with ensnared powerful figures atop international governments, entertainment, media, science, education and big business.

Two days after the *Axios* bombshell at a cabinet meeting on Tuesday July 8th, [a reporter](#) asked:

Your memo on Jeffrey Epstein left some questions, and one of the biggest ones is whether he ever worked for an American or foreign intelligence agency. The former Labor Secretary who was former Miami US district attorney [Alex Acosta](#) allegedly said that he did work for an intelligence agency. So could you resolve whether or not he did, and also could you think why there's a minute missing from the jailhouse tapes?

Trump interrupted to chastise the reporter for even daring to bring up his Epstein Pandora's box that a riled up, angry Trump is clearly trying to bury:

Are you still talking about Jeffrey Epstein? This guy's been talked about for years. We have Texas, we have this, we have all the things that, and all this... And are people still taking about this guy, this creep? That is unbelievable. I can't believe you're asking a question about Epstein. At a time like this where we're having some of the greatest success and also tragedy with what happened in Texas, it just seems like a desecration.

Pam Bondi went ahead and answered the reporter's question as if to put the final punctuation mark on the entire DOJ/FBI Epstein affair:

In February, I did an interview on Fox. And it's been getting a lot of attention, because I was asked a question about the client list. And my response was, 'It's sitting on my desk to be reviewed.' Meaning the file — along with the JFK, MLK files as well. That's what I meant by that. Also, to the tens of thousands of videos, they turned out to be child porn downloaded by that disgusting Jeffrey Epstein. Child porn is what they were. Never going to be released, never will see the light of day. To him being an agent, I have no knowledge about that. We can get back to you on that... The video was not conclusive, but the evidence prior to it was, showing he committed suicide. And what was on that — there was a minute that was off the counter. And what we learned from Bureau of Prisons was every night they redo that video — it's old...from like 1999...so every night the video is reset. And every night should have the same minute missing. So we're looking for that video to release that as well, showing that a minute is missing every night. And that's it on Epstein.

Pam Bondi's flat out lie that no blackmail evidence of a list of Epstein's VIP pedo-clients exists while his convicted partner-in-crime Ghislaine Maxwell sits 20 years in prison for her part in their Israeli military intelligence child sex trafficking operation spanning close to two decades. Ghislaine is serving a 20-year prison sentence for [sex trafficking](#) underage girls. As the youngest daughter of superspy-media mogul Robert Maxwell, who worked for Mossad, MI5 and plausibly the KGB, first introduced his favorite daughter to Epstein early on in the 1980s. This was confirmed by former Israeli military intel official from 1977 to 1987 [Ari Ben-Menashe](#), who publicly disclosed that he was introduced by Robert Maxwell to Epstein in the mid-1980s while all three were actively involved working with Saudi billionaire arms dealer Adnan Khashoggi during the Iran Contra scandal.

To sidetrack exposing the truth, Bondi suddenly switched gears going from [Epstein files](#) on her desk for review to now "disgusting Epstein's downloaded kiddie porn" that will never be opened to protect the victims. Total avoidance of the glaring, overwhelming reality in order to protect all the perpetrators and virtually everyone in the world knows it's to protect Epstein's #1 perp buddy — [Donald Trump](#). This total whitewash is unacceptable, but sadly in line with what I've been writing seemingly forever, in scandal after scandal confirmed in my [Pedophilia & Empire](#) 5-book volume [series](#), gatekeepers always remain protected.

Trump risks such a backlash now after reneging on one campaign promise after the next, and many are now calling for Bondi's resignation. Cracks even within Trump and Bondi's stonewalling regime over the Epstein files appear to be emerging now. FBI's Kash Patel and Dan Bongino are allegedly steaming after a heated confrontation with Pam Bondi. According to a July 11th [Daily Mail](#) exposé:

President [Donald Trump](#)'s [FBI](#) head Kash Patel and deputy Dan Bongino are both ready to call it quits if Attorney General Pam Bondi keeps her job after the debacle over releasing the [Jeffrey Epstein](#) files.

The City of London moneylenders responsible for the global pedophilia scourge as the primary means of sexually blackmailing and totally owning and controlling political puppet gatekeepers is to ensure that their perversions are captured [on tape](#) in order to hold the criminal evidence over all their dupes, like [Trump](#) the rest of their lives.
