A short take on European history

The British Empire has always hated the Russians and the British orchestrated the Bolshevik revolution as the strategic objective to “create” the conditions of global hegemonic control by the British One World Government.

AI overview states that Operation Barbarossa was the “code name for Nazi Germany's large-scale invasion of the Soviet Union, launched on June 22, 1941. This invasion marked a turning point in World War II, opening the Eastern Front and ultimately contributing to Germany's defeat. The operation involved around 4 million soldiers across a 2,000-mile front, making it the largest military offensive in history”.

The Russians were the then cannon-fodders for the British Empire. And today, the Russians are once again the cannon fodders in the Ukraine war in the British

Empire's strategic planning, that the defeat of Russia in Ukraine or a much weakened Russia cannot and would not be able to come to the aid of China when the total war is waged against China. The Opium war subdued the Chinese, but China was not conquered.

The final defeat of China would enable the British Empire to be the supreme global power and the gullible Americans the "bully boys" doing all the heavy lifting.
